Changing areas	Staff and pupils	<ul> <li>If used, these should be cleaned after every lesson – Wiping of surfaces is a reasonable approach. Attending school with PE kit on will limit the need to use changing rooms in line with whole academy policy.</li> <li>Social distancing measures still apply and marking out areas which cannot be used will help manage the area effectively. Movement between the changing rooms/ hall/ field and around the building particularly between entry and exit points are staggered and controlled to avoid any congestion at busy points.</li> </ul>	4	2	8	DBN/SCE PE staff
Communication	Staff and pupils	<ul> <li>Previous PE risk assessments are reviewed, and all safety measures are still followed and changes made to adhere with government guidance e.g no contact sports. Social distancing	Staff and pupils	Students are reminded about social distancing and are given allocated areas to work from.Group size is reduced where possible depending on size of bubbles and groups stay within their allocated bubbles.Smaller bubbles may be formed within the bubble depending on the size of the original group.	4	2	8	All PE staff
PE clothing	Staff and pupils	When PE takes place students will wear their PE kit to school – this only occurs when PE is scheduled on the timetable.	4	2	8	All PE staff
